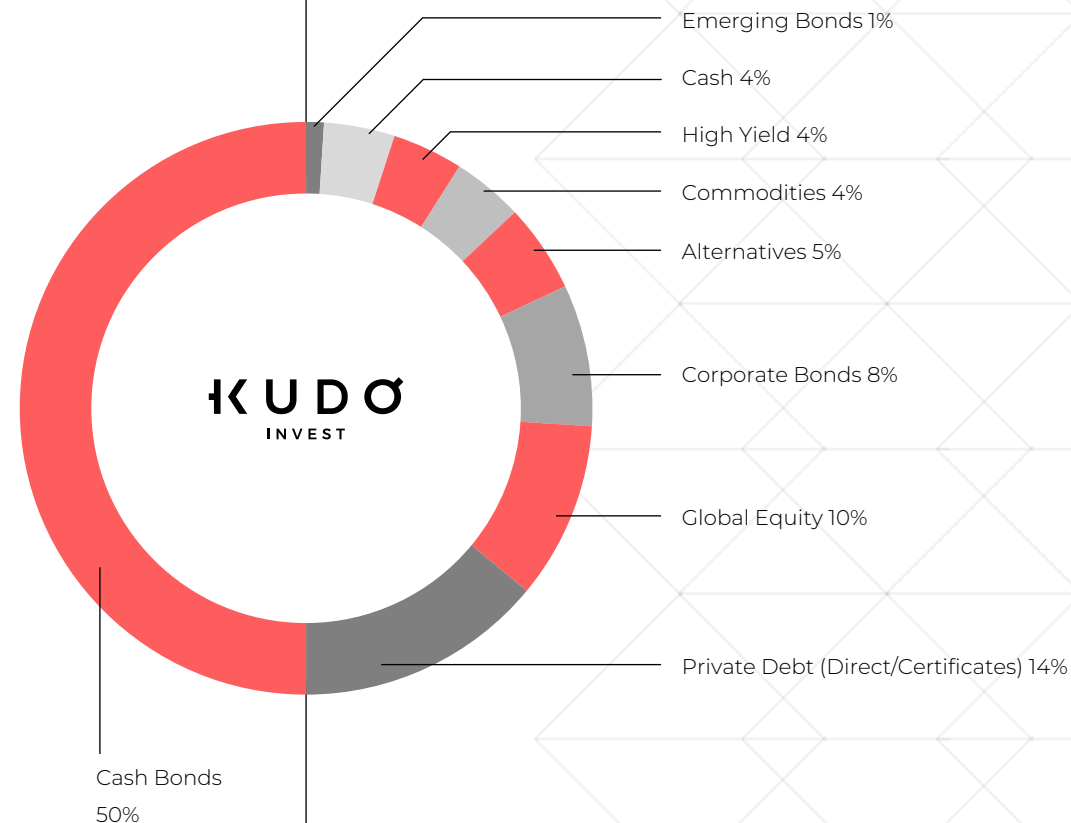

- Dynamic asset management according to market vision.

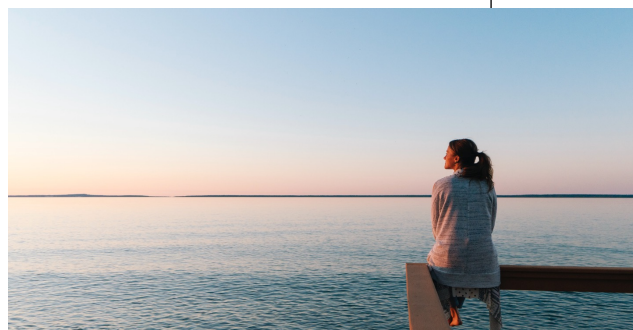
